**BOARD OF HEALTH
MEETING**

OFFICIAL PROCEEDINGS

A general meeting of the Central District Health Department (CDHD) Board of Health was held Monday, November, 2025, 6:00 p.m. at 1137 S. Locust St, Grand Island, NE. Vice President Cody Rush called the meeting to order at 6:00 p.m. and announced the location of the Open Meeting Act. Legal notification of the meeting was published November 12, 2025, in the Grand Island Independent.

RESERVATION TO SPEAK: Yes, Debra Potratz of 814 Sweetwood Drive, Grand Island NE 68803, reserves the right to speak on retirement fund transfer payments. Debra states she did not receive adequate notice transferring her retirement funds which caused her to lose approximately \$4,500. She asks the board to consider repaying these funds.

EXECUTIVE SESSION: Pam Lancaster (McDonald) made a motion to enter executive session to discuss retirement fund transfer payments. Roll call vote: Aye- Rush, Wiemers, Lacore, Fruehling, Wiegert, Calvillo Bermudez; No-O'Neil. Motion carried. Executive session entered at 6:03pm.

Teresa Anderson committed to collecting recommendations for recruiter agencies specific to public health to contract in the search.
